**DEALER AGREEMENT**

1. The fee for one 6' space (6' x 30" table & 2 chairs) is \$160.
2. Sales merchandise is limited to doll house miniature related items, supplies and tools only. Dealers must keep their merchandise within their assigned table space.
3. Dealers will supply their own heavy duty extension cords.
4. Dealers must have tables set up for the entire 2-day show. No packing before 4 PM Sunday.
5. Cancellations must be made in writing or in email at least 30 days prior to the Show to receive a refund. Space is reserved upon receipt of signed contract and payment in full.
6. Small World Miniature Club and Glendale Community College cannot accept any liability for stolen merchandise or personal injury to dealers or helpers.
7. "Sale", "Discount" and "Going out of business" signs and fliers will **not** be allowed.
8. Smoking is not allowed anywhere on campus.

Dealers are responsible to collect all sales tax on retail sales. You must have an Arizona Tax License. If you do not have an Arizona Tax License, you may obtain one from the AZ Dept. of Revenue. You are responsible for filing this tax. We can no longer collect any taxes.
